The Education Fund supplements those volunteers with direct grants to teachers and principals focused on improving literacy in their classroom or school, and uses data analysis to identify which individual students or groups of students need our support.

4b (Code: ) (Expenses \$ 148710. including grants of \$ 19209. ) (Revenue \$ ) The Math Program works in 4 high need middle schools to place trained math volunteers in classrooms, provide math related grants to educators, and targets the students most in need. In high school, the Education Fund shifts its emphasis to our College & Career Readiness Program.
